ORDER CREATING FRENCH CREEK WATERMASTER SERVICE AREA
SISKIYOU COUNTY, CALIFORNIA

WHEREAS Section 4026 of the California Water Code authorizes creation of watermaster service areas as rights to water are ascertained and determined; and

WHEREAS the rights of the various claimants to the use of the water of the French Creek stream system in Siskiyou County, California, have been established by decree No. 14478 entered by the Superior Court, Siskiyou County in the case of John H. Mason, et al vs Harry M. Bemrod, et al, dated July 1, 1958; and

WHEREAS the most practical and economical supervision of the distribution of the waters of the French Creek stream system may be accomplished by the creation of a Watermaster Service Area covering such lands as will include all of said water rights, excepting the rights from springs and unnamed streams as shown on Table 1, page 17, of the above mentioned decree.

NOW, THEREFORE, it is hereby ordered that a Watermaster Service Area be and the same is hereby created, as provided in Sections 4025-4032, Chapter 2, Part 4, Division 2 of the State of California Water Code, said Watermaster Service Area shall comprise those lands described in Exhibit A, appended hereto and made a part hereof. Said area shall be known as the French Creek Watermaster Service Area.
